Advertising as a Christian Science Nurse in *The Christian Science Journal* and *The Herald of Christian Science*

Applications for advertising are accepted by the Board of Trustees of The Christian Science Publishing Society (CSPS). Membership in The Mother Church and Primary class instruction are requirements for advertising. After acceptance by the Trustees, an advertiser's card will be inserted in *The Christian Science Journal*. Advertisers may list in editions of the *Herald* only in addition to their listing in the *Journal*. Applicants accepted for *Herald* listings must be able to read, write, and speak the language of each *Herald* in which their listings appear. The language designation symbol (°) in the *Journal* means the advertiser does not speak or write English.

Primary card

The primary card listing must be in the town where the Christian Science nurse is located.

- Must contain name, address (or PO box), and phone number.
- Telephone may be home and/or cell (mobile). Toll-free (free phone, e. g. 800), fax, and pager numbers may also be included.
- May not list the address of a Christian Science nursing organization unless it is also his or her residence.
- Electronic addresses (such as email, URL, IM id, VoIP) are optional. No email addresses associated with Christian Science nursing organizations are accepted. All electronic addresses are in lower case.
- Phone lines and electronic formats for communication must be private, with all communications received solely by the advertiser.
- Only one address and only one email address may be included *per card*.

Cross-reference

Advertisers may also have a cross-reference in a nearby metropolitan area, the town where he or she attends a branch church, and/or a second (e. g. seasonal) residence. There is an additional charge for each cross-reference.

- Contains only name, direction to primary listing (e. g. "see Dallas, TX"), and one phone number.
- If the primary listing is in another country, an additional telephone number may be listed.
- Contains no postal or electronic addresses.
- May have a cross-reference under "Able to Travel" if able to accept cases at a considerable distance.
- Temporary cross-references may be inserted for 3-12 months when advertiser has moved to a new location and/or has a name change.

Online listings are identical to the print version of the *Journal*

Changing Card Information

All changes should be submitted, only by the advertiser, to the CSPS in writing by email, fax or letter. There is a charge for changes.

Removal of Cards

An advertiser may request the removal of his or her card by telephone or correspondence. According to Article xxv, Section 9 of the *Church Manual*, an advertiser's card also may be removed by The Christian Science Board of Directors.

Reinsertion of Cards

Cards may be reinserted, within twelve months of card removal, after a reinsertion form has been submitted and accepted by the Board of Trustees. A new application must be completed if an advertiser's card comes out, for any reason, for more than one year.

Charges for Advertising

Charges for advertising are billed annually and payable upon receipt. Charges are explained in the *Journal* Directory under "Instructions for Advertisers." Non-payment by the renewal date will be considered as the advertiser's intention to have the card removed.
